Departmentally approved common syllabi are provided to instructors. Common exams or assessments are used in some departments. Schoolcraft has developed a Center for Faculty and Academic Excellence to provide technology, space for collaboration and reference materials to faculty members. Faculty members have access to technical support and training. A wealth of library resources and databases offer easily accessible peer reviewed journals and other academic literature.
