## **GED**<sup>®</sup> Test Responsibility Statement

Each GED<sup>®</sup> test candidate is responsible for accurately entering in identification, address and other pertinent information requested. Any incorrect information may delay score reporting or result in the issuing of an inaccurate GED<sup>®</sup> test certificate or official score report. State of Michigan GED<sup>®</sup> certificates will not be reissued to correct any candidate errors or information changes.

The GED<sup>®</sup> candidate is responsible for acquiring instruction and practice with the official Casio fx 260 solar calculator before he or she comes to the test session. Individual instruction on calculator use will not be given by the GED<sup>®</sup> examiner.

**The following items are not permitted in the testing area:**

- Purses or tote bags
- Cell phones or any other electronic device
- Food and beverages
- Jackets, coats, and hats
- Books, notebooks, paper or any other supplies
- Any other nonessential items

**If during or after testing we find any of these items at your desk or on your person, we will collect your test materials and your test will not be scored. You will then be required to leave the testing center. You may not reschedule your test without the Chief Examiner's approval. This could be up to six months. If we find a cell phone with you during the test, the phone will be sent to the State of Michigan for examination. It may be several months before it is returned to you.**
