I understand that my class(es) will be held temporarily for the Fall 2025 semester only. This hold only waives the upfront payment requirement on tuition and fees and does not make funding available at the bookstore.

I realize that I am financially responsible for all charges and that they must be paid in full by the indicated semester date to remain enrolled. Payment must be in the form of approved financial aid and/or cash, check, or credit card.

It is my responsibility to drop from all my classes if I am unable to pay for them. It is also my responsibility to know the dates that apply to my classes.

I understand this form will NOT be accepted if Schoolcraft does NOT have my 2025-26 FAFSA on file with all Verification completed (if Verification is required).

## **Community College Guarantee Eligibility Requirements for 2025 High School Graduates**

- Be a MI Resident since July 1<sup>st</sup>, 2024 (for dependent students, this applies to Parent residency status)
- Be a U.S. Citizen, Permanent Resident, or Approved Refugee

**STUDENT SIGNATURE (must be handwritten)** 

- Graduate from a Michigan High School (with diploma, certificate of completion, or high school equivalency)
- Submit proof of Michigan high School completion to Schoolcraft College
- Be a Regularly Admitted Student to Schoolcraft (not guest or dual enrolled student status)
- Be enrolled full time (12+ credits) in a semester to receive funding
- Maintaining Satisfactory Academic Progress to maintain funding in subsequent semesters (GPA 2.0, 67% completion rate, under 90 earned credits)
